I hereby acknowledge that if I continually fail to pay any fees or charges when due, then the annual play pass fee shall automatically terminate at the option of Putnam National and Putnam National shall be entitled to retain any and all portions of the annual play pass fee previously paid as liquidated damages and not as a penalty and shall have no obligation to refund the annual play pass fee or any portion thereof, whereupon I shall be released from all liability hereunder. **ACKNOWLEDGMENT OF ANNUAL PLAY PASS RIGHTS**

**I acknowledge that annual play pass at Putnam National permits the me to use the Club Facilities at Putnam National and is not an investment in the Company, the Club, or the Club Facilities. Use of facilities is based on availability; the club reserves the right to conduct group and or outing business on any day or at any time as the club sees fit and in their best interest.**

An Annual Play Pass at Putnam National does not provide any equity or ownership or any other property interest in the Company, the Club, the Club Facilities, their respective operating companies or facilities, or a vested or prescriptive right to use the Club Facilities. An annual play pass holder only acquires a revocable license to use the Club Facilities in accordance with the terms and conditions of the club, as the same may be amended from time to time, as may this Annual Application & Agreement. Putnam National, in their sole discretion, reserves the right to terminate or modify their respective annual plans and rules and regulations, including without limitation, the use privileges of annual play pass programs, to reserve annual play passes; to add, issue, modify or terminate any type, category or class of annual play pass, to recall any annual play pass at any time for any or no reason whatsoever, and to make any other changes in the terms and conditions of the annual play pass or the facilities of such clubs available for use by annual play pass holders.

I hereby acknowledge that the use of the Club Facilities and any privilege or service incident to the annual play pass is undertaken with knowledge of risk of possible injury. I hereby accept covenants and agree to indemnify and hold harmless the Club and its Pass Holders, partners, shareholders, directors, officers, employees, representatives, affiliates and agents in accordance with the provisions of the annual play pass plan and the rules and regulations of the Club.

In the event of death to a designated play pass holder, the surviving spouse, if any, may elect to: (i) continue the annual play pass privileges without having to pay any additional annual play pass dues, fees, and charges; (ii) resign the annual play pass, in which case the annual play pass dues and fee will be refunded, if approved, on a prorated basis; This prorated credit, if approved, will be refunded upon the completion of the current annual play pass year; or (iii) designate one adult child or one adult beneficiary to acquire the annual play pass without payment of any annual play pass dues, fees, and charges, subject to the approval of the adult child or adult beneficiary for annual play pass in the Club, by giving written notice to the Club. Failure of the surviving spouse to elect one of said alternatives within 90 days after the death of the designated Pass Holder shall be deemed an election to continue the annual play pass privileges. In the event there is no surviving spouse, no adult child, or no adult beneficiary who wants to continue annual play pass privileges or who is approved for annual play pass in the Club, the annual play pass shall be deemed resigned, and the annual play pass dues and fees previously paid for the annual play pass will be deemed non-refundable.

In the event the Club, in its sole discretion, approves an annual pass holder's request for a temporary downgrade to an inactive status due to medical circumstances or a refund due to the relocation of the designated pass holder's primary residence being outside a fifty (50) mile radius of the Club, either of which results in an inability for the designated pass holder to use the annual play pass. *(The designated pass holder shall be required to provide documentation from a mortgage company evidencing the change in the primary residence.)* The Club, in its sole discretion, may approve a prorated credit for the annual play pass dues and fees previously paid for the annual play pass. This prorated credit, if approved, will be applied to only future annual play passes, group play and/or other use services or fees at the club. The designated Pass Holder shall be required to provide documentation from a treating physician evidencing the medical condition. The minimum term for an inactive status for medical reasons shall be six months. For continued inactive status beyond the minimum term, the designated pass holder shall be required to reapply for such status. The Club reserves the right to discontinue or modify the medical hardship inactive status program in its sole discretion.

- This Annual Play Pass Application & Agreement shall be governed by and construed and enforced in accordance with the laws of the state in which Putnam National' facilities are located without giving effect to principles of conflicts of law. I understand that annual play pass is contingent upon approval by Putnam National, which approval shall be at its sole and absolute discretion.
- This Annual Play Pass Application & Agreement shall not be binding to Putnam National until the acceptance of both parties as indicated below.
